- 2 Parent Governors / 1 Headteacher / 1 Staff / 1 Local Authority / 4 Co-opted Governors / 3 Foundation Governors
- \* Foundation Governors are appointed by the Diocese of Lincoln Board of Education, the Authority Governor is nominated by the Local Authority, Parent Governors are elected by the parent body and Staff Governors are elected by the staff body of the school.
- \*\* All Governors' terms of office are 4 years.
